Since 1983, MADRE provides human rights trainings, capacity-building, technical assistance and other forms of support to nearly 90 community-based women's organizations in over 25 countries, directly impacting the lives of approximately 450,000 people. MADRE understands that human rights are not a hierarchy, but an indivisible set of standards for all people to enjoy. MADRE's focus is on delivering results to women and families worldwide - meeting both immediate, local needs and creating sustainable, long-term systemic change.

MADRE's programs reach communities in Afghanistan, Colombia, Guatemala, Haiti, Iraq, Jordan, Kenya, Nicaragua, Palestine, Panama, Peru and Sudan. These programs directly impact approximately 30,000 women, children and men each year. Their ages range from a few months to 70 years, but the majority are under the age of 35. Almost all live in extreme poverty, subsisting on less than \$1 a day. Project participants are mostly unemployed or under-employed and a significant number are at risk for unplanned pregnancy, domestic violence, and/or substance abuse. They lack access to formal education, healthcare and other basic services, and many suffer from preventable, poverty-induced health issues such as malnutrition.
