MADRE is an international women's human rights organization that works in partnership with community-based women's organizations worldwide to address issues of peace building, economic and environmental justice, women's health, and violence against women. Since 1983, MADRE has provided human rights trainings, capacity-building, technical assistance and other forms of support to nearly 90 community-based women's organizations in over 25 countries directly impacting the lives of approximately 450,000 people. Today, our work empowering grassroots women to create social change benefits some 100,000 people per year. MADRE's focus is on delivering results to women and families worldwide—meeting both immediate, local needs and creating sustainable, long-term systemic change to realize human rights for all.
